

REQUEST FOR EXPRESSIONS OF INTEREST

Contract Title: Tender for ‘Provision of maintenance and repair services, including spare parts, for hot water boilers, hot water and steam boilers, and auxiliary installations operated by OMV Petrom’.

OMV Petrom S.A. is interested in concluding a Service Procurement contract for the provision of maintenance and repair services, including spare parts, for hot water boilers, heating water boilers, and steam boilers, as well as auxiliary installations operated by OMV Petrom.

OMV Petrom owns several types of hot water boilers, hot water heaters, and steam boilers, operating in various production locations across the country. In order to ensure the continuous and safe operation of installations including hot water boilers, hot water heaters, and steam boilers, it is necessary to provide repair and maintenance services for them, including the replacement of necessary spare parts.

It should be noted that the thermal power plants that are the subject of this service procurement procedure are used for producing the thermal agent necessary in technological processes of gas stripping/de-ethanization of well gases, thermal and chemical treatment of crude oil, steam injection into wells, in a potentially hazardous, explosive work environment.

The production of thermal agents for technological processes takes place on land and on offshore platforms. It is a specific activity of the oil and gas industry, posing a high risk to the health and safety of personnel, the environment, and potential losses of production and material assets, and cannot be considered similar to other types of activities (such as producing hot water for domestic hot water and central heating or producing thermal agents for technological processes with low risk in other industries).

Maintenance and repair services, including spare parts, for boilers and auxiliary installations existing in OMV Petrom Assets consist of the following main activities:

- maintenance and repairs including spare parts/materials;
 - relocation of previously operated boilers and auxiliary installations to another site. This includes dismantling, cleaning, handling, loading/unloading, transport, inspection, installation of hot water/steam boilers or auxiliary installations at another location, (re)calibration, and commissioning;
 - preparing equipment for ISCIR inspections for verification, authorization, and reauthorization;
 - preparing the necessary documentation and obtaining ISCIR approvals/authorizations.
 - Verification, Inspection, Examination, Testing services aimed at identifying defects, following repairs, as well as for periodic technical inspections, authorization/re-authorization;
 - Transport to the Site - refers to services related to the travel of the Contractor's personnel and/or the transport of spare parts and materials to the Site.
 - Technical support upon the Beneficiary's request - includes both remote technical support and on-site support in the production area to carry out checks and optimize parameters for hot water/steam boilers and auxiliary installations. Remote technical support will only be provided during regular working hours.

- Training of operating personnel, concluded with the signing of a training report, if modifications were made to the plant or auxiliary installations.

Contract duration: 36 months, prolongation being an option.

OMV Petrom S.A. invites eligible companies to express their interest in supplying the goods mentioned above. Interested companies will provide information that proves they have the relevant qualifications and experience in implementing the contract (brochures, description of similar contracts, experience in similar conditions, etc.)

In the case of an association, the information mentioned above will be provided for all members of the association.

All companies that will express their interest in participating in the procedure organized by OMV Petrom will be invited to submit their offer.

The companies will receive the tender documentation and will be invited to submit a bid through the Ariba tender platform.
