OMV Petrom S.A. is interested in concluding a services frame contract for: "Submersed Lift Pumps HPU Health Care" for Neptun Asset.

Neptun Deep is a proposed offshore natural gas development in the Neptun Deep block, located in the Romanian sector of the Black Sea. The objective of the Neptun Deep project is to develop the natural gas reserves from the field. The gas fields are tied back to a normally unmanned Shallow Water Platform on the continental shelf. Sales specification gas is piped onshore to a Natural Gas Metering Station, before entering the Transgaz National Transmission System (NTS).

In support of Neptun Asset, OMV Petrom S.A. is seeking a contractor for Submersed Lift Pumps HPU Health Care.

The objective is to cover all maintenance, health care and troubleshooting services for the FRAMO packages installed on the Neptun Deep Alpha Platform.

The purpose of the purchase for the services and products is to maintain the FRAMO packages in working condition to always ensure 100% operational availability in compliance with the applicable standards, specifications, procedures, and relevant safe regulations in a planned and organized manner.

The equipment included in the FRAMO package are listed below:

- SEA WATER LIFT PUMPS PACKAGE – including Pump, FCU (Fluid Circulation Unit), Bend Top, Pipe stacks
- HYDRAULIC SUBMERSIBLE PUMPS PACKAGE (CARGO) – including Pump and HPU (Hydraulic Power Unit)

CONTRACTOR must perform regular maintenance services or upon COMPANY request.

The maintenance activities will address all equipment within the FRAMO packages (e.g. mechanical, electrical, instrumentation and automation, hydraulic system, electric motors / fans, coolers, ancillary equipment, safety devices) and when required the supply of spare parts or consumables. Additional, upon equipment service life or based upon condition, will be required overhaul in FRAMO specialized facility.

Maintenance services includes transport, inspection and necessary recalibration, disassembly, repair, refurbishment or replacement, failure reports debugging and re-assembly, testing of equipment, certification as described herein.

Estimated duration of the Frame Contract: 5 years

OMV Petrom S.A. invites eligible companies to indicate their interest via an Expression of Interest letter attaching a description of the interested company, including any affiliates, contact data/ information (company name, representative person name, email address, phone number etc), presenting their

relevant experience to perform such contracts (brochures, description of similar assignments, track record of similar experience).

Any potential joint venture/association should provide the above-mentioned information for all the partners of the association.

The tender process will be conducted using the SAP ARIBA platform. Companies must ensure they are registered in the SAP ARIBA platform or will register themself on this platform upon receiving an invitation to register from OMV Petrom S.A., as this is a necessary condition to participate to this acquisition process.

After companies are registered in SAP ARIBA platform, a mandatory pre-qualification questionnaire shall be completed in SAP ARIBA by each registered company. Only pre-qualified companies will receive the bidding documents.

We highlight the fact that in case of awarding the contract, according to the obligation provided by article 23 of Romanian Law 256/2018 regarding certain measures required for the implementation of petroleum operations by the titleholders of petroleum agreements relating to offshore petroleum blocks, if the Contractor is non-resident, it shall establish and maintain throughout the entire duration of the Contract a branch or subsidiary headquartered in Romania, according to the legal provisions in force, within 30 days from the execution date of the first Contract.
